In failing to recognize Fontaine's unique personal identity and circumstances, her murder is seen as separate from the countless missing and murdered Aboriginal women who came before her. And thus, its significance as a trend dating back to colonialist policy is wrongly discounted. Despite your denial and treatment of the case as a regular crime, it is doubly dangerous to exist as an Aboriginal and a woman in Canada.

We hope you reconsider your public position on this matter.

The death of Tina Fontaine should not be seen as the death of an individual but rather as evidence of a larger problem within Canadian society. Without value, they are twice as likely to be victims of violent crimes such as murder and rape. Through Canada's history of colonization, class systems and patriarchal structures, we have created this reality in which 15 year old girls like Tina Fontaine are found dead in the river.

You, Prime Minister Harper, and we as Canadians need to take responsibility for our role concerning missing and murdered Aboriginal women. The first step in this long process is a National Inquiry that you have, up to this point, ignorantly refused.
